- Remote Access Statement & ground rules for hearing
- Proposal review
 - Here to consider the land use change
- Read letter submitted from Barb Martin
- Hope Blucher Easy Street
 - Been there for 53 years
 - Has felt vibration from pit
 - Fumes from the asphalt plant
 - The impact of request
 - Footprint would be increased by 12 acres
 - Closer to Easy Street
 - Rural and Residential
 - Main problem with the request
 - Being made from one person and benefits one business
 - Town Plan is for everyone
 - Isn't fair to make such a huge change
 - Not in Favor of the change, doesn't stay with town plan
- Barb Martin
 - South Main Street, moved here 40 years ago
 - One simple decision can
 - Town Plan clearly indicates the area rural, residential and why it is classified as is
 - Concerned citizens have asked for a site visit
 - Being in the area would be beneficial to understand the size
 - This needs to be set aside until a new town plan is done
 - The village is disappearing
 - Less children, possible school closing
 - Our own select board is fighting against town plan

- Tary Jesmonth
 - Easy Street
 - Years ago when the land was bought purpose to keep it from being developed
 - Closer to his residence, would not like further damage to home
 - o Should be left alone, shouldn't come further towards homes
- Lynn Bondurant
 - Thanking the planning commission for having the meeting
 - Appreciates the business and what is provides
 - The property has been stated as being landlocked
 - Connected to a larger piece of property that is not landlocked
 - Understanding that this is the only possible use for it
 - Danby has a long standing against zoning
 - Spot zoning feels like for changing designation for one person/business
 - Consider overall public good for the town
 - o Consider the entire issue and impact
- Ingrid Halligan
 - o Confusion with the proposal
 - Impact on property values
 - 30% impact
 - Statements in proposal
 - Grandfathered in for the initial
 - 100 year lease originally north of town
 - Wondering about it being engineer
 - Blasting laws have not been updated in a long time
 - The last blast felt movement in the house
- Tricia Katz
 - North Main Street, been here for 4 years
 - o Get some place quiet and calm
 - Was not aware when they first moved about blasting
 - Could get notification before happening
 - Brought back trauma from a prior experience
 - o Community needs to stick together
 - o Honest and considerate of neighbors
- Tracey Porter
 - o Presenting Petitions
 - Tax payers & Voters
 - 173 registered voters
 - 7 tax payers
- Planning Commission
 - Would like to handle the petition in the proper manor
- Sue Crosby
 - Lived in Danby in 54 years
 - Had a business in town for a long time
 - Considering moving if this is passed
 - Fumes, blasting are too much

- Value of home is depreciating
- Andrea Martin statement to be read
 - Danby Pawlet Road
 - For many people their homes are all they have
 - Drops in value based on distance from quarry
 - Property tax income could stall
- Bill Payne
 - Requesting a site visit
 - In an environmental hearing there is typically a walk through
- Cathy Jesmonth
 - o Easy Street
 - o Laid out visualization of area
 - Clarification of the area
- Dana Heleba
 - Borders the Whelan lot
 - The forest land is not active
 - The plant is not moving, regardless
 - o Agrigate will be brought in
 - Better for land to be used that isn't being used
- Ingrid Halligan
 - Reason this is happening
 - He continues to get permission to take more of the town
 - An action suite could be brought
- Cheryl Bicskei
 - Asking a few questions to the board
 - Baker Brook rd 42 years
 - How many were appointed with Tom on the Board
 - How many are friends
 - Major change to the plan and the village
 - The people voted the town plan through
 - Can you assure the majority of the people in the town plan
 - Can it go for a public vote?
 - Should remain consistent with the town plan
 - Amendments should be voted on by the town
 - Here to support, doesn't directly affect
 - Better fit to have it go as a town wide vote, instead of a board
 - Testimony should be considered
 - Would be more legitimate if it was a town vote

- Asphalt fumes
 - This plan is not asphalt expansion
- Seems like it will change the character of the town
- Goals for the future
 - Promoting health safety and general welfare of the people
- Business that is been here a long time that employees people
- Quality of Life
- Anne Marie Hodgin
 - o Raiches cross road
 - Are we supposed to get a notice of blasting
 - Main concern around water system
- Dana Tifft
 - Base of Easy Street
 - Not home during blasting
 - o Trusts his neighbors statements
 - Has looked at the land and measured from front door
 - Less than 500 yards
 - Does not want expansion
 - Understand he is a businessman
 - Last year the blasts were asked to be measured in the area
 - Feels it should go to a town vote
 - Owe it for the vote to happen
 - Go with the majority of the town vote
 - Were the tests done and are results available
- Chris Hardaway
 - South Main Street
 - Hasn't heard a lot of support around the quarry
 - o Would like information to be included in the recommendation as to why it is positive
- David Lindenberg
 - o Important that more information needs to be known before the recommendation is made
- Does the planning commission have the authority to recommend something to be put to a town vote
 - Could a recommendation be made to the select board for a town vote
- Craig Moran
 - Health point of view
 - Things are not good for health
 - Danby is a beautiful historical village
 - Does not want to see that threatened
 - Wonderful history
- Cheryl Bicskei
 - o Offended that statements were taken as a threat
 - The board voted less than a year ago

- Seems like unethical behavior
- Beth Thompson
 - Clarrifcation on recommendation
 - Amendment, town vote
- Annette Smith
 - Baker Brook Rd
 - Doesn't know acreage of existing quarry
 - New are looks larger
 - Didn't understand the elevation of the land that could be removed in village
 - Before the meeting drove down
 - Wouldn't know there was a quarry in town
 - Asking questions
 - Has anyone experience the issues brought up
 - Could there be a test blast
 - So people could understand
 - Causing issues already
 - Read statement
 - Issues for the village
 - Comments
 - Danby Village has a designation
 - Existing extraction
 - Negative affecting village
 - Property values have decreased
 - Dust, fumes
 - Quarry is deep enough to impact ground water
 - Village has existed longer with out a quarry
 - Business owners
 - Incompatibly with town plan
 - Prioritize people and homes or one business owner
 - Adding to the harm of the people
 - Has worked with a lot these issues in the past and similar issues
 - Approval of amendment that towns people would have to continue to fight
 - Do not support
- Andrea Myklebust
 - o Been here for about 6 years, easy street
 - Urges not to change
 - Will change the character of the historic village
 - Records of when blasting has occurred over the past few years
 - Closest full time resident to town water supply
 - Water was affected after a blast
 - Well was cloudy, silty after a blast
 - Trying to have civil conversations is important
 - Expressing an opinion
 - Was personally attacked by someone who works at the quarry
 - o Real life, of people living together
 - What is best for the community

- Dana Heleba
 - Value property
 - Property went up \$50,000 is the last sale
 - Hasn't seen a tax difference
- Tom Fuller
 - o Project is 11.87 acres
 - Comparison of size for the of property in the town
 - Boarders an active quarry
 - Makes sense to be part of the quarry
 - Access already goes through a commercial area
 - Direction of the project goes towards vacant land
 - Proven natural resource
 - In the 60s 70s there was extraction in the area
 - o 1100 ft from the town border to rt7 & Mt. Tabor
 - On the edge of town going right to rt 7
 - o Town has always benefited from the resources
 - There are no other logical uses for the land
 - o Wondering about statements around town plan amendments
 - Concern in general
 - Bullying that went on during the petition signing
 - Discouraged, making people feel bad about not signing and should not live here if they do not support it
- Tricia Katz
 - o Has seen trucks going up and down south main street
 - Not necessarily going the direct route to rt 7
- Cathy Jesmonth
 - Outside trucks going to area, not just the operation trucks
- Dave Powers
 - There was statement in proposal about no additional truck traffic
- Tracey Porter
 - o Trucks on south main on trucks that shouldn't be on south main
 - o Pictures of said vehicles on road
- Dana Tifft
 - Question to Tom Fuller
 - Were the tests done
 - Where are results available?
 - Requestions copies of results
 - To Planning Commission
- Cathy Jesmonth
 - Wondering about notice of blasting
 - o Could there be a siren again?
 - Notice can and will be given if requested
- Where were the tests done
 - Location
- Cindy Crandall
 - o People were not forced to sign petition

- o Was respectful about requesting petition signing
- o How many people were forced?
- Planning Commission set next meeting to hold a vote
- Next meeting will be July 8th at 7pm at town office
 - o Online and in person
 - o Meeting to discuss and vote on recommendation
